Re: PPP Loan Forgiveness Services

To assist you with gathering and analyzing the financial data needed to prepare and submit the Paycheck Protection Program (PPP) loan forgiveness application, the Archdiocese has reached an agreement with CliftonLarsonAllen LLP (CLA) to provide loan forgiveness services to you at a discounted price.

Benefits of utilizing the service packages offered by CLA include:

- An application tool that has been developed by CLA experts on the PPP*
- CLA is committed to continually updating the tool as necessary based on any future changes in the PPP loan forgiveness regulations
- Minimize potential for errors and oversights
- Maximize possible forgiveness under current rules and regulations

Basic

- CLA completes the forgiveness application and any supporting spreadsheets required by the bank
- Two consultative meetings (estimated 2 hours in total) to discuss items needed for preparation of the application tool and an exit meeting to discuss the forgiveness application once finalized prior to submission to the bank.
